Response Exercise 2009 Full Scale Earthquake Exercise Elk Grove, California October 10, 2009

This exercise is open to CERT members at all training levels

Response Exercise 2009 is a full scale disaster exercise designed specifically for Community Emergency Response Teams (CERT). Hosted by the Capital Area CERT programs and sponsored by California Volunteers and the Sacramento Urban Area Security Initiative, this year's exercise will be held in Elk Grove, California.

A significant earthquake has caused severe damage and compromised the ability of public safety agencies to meet the response demands of the Elk Grove area. A request is made for mutual aid response including CERT members.

Participants in this exercise will have the opportunity to arrive and check-in at an established incident Base Camp; they will receive an Incident Action Plan for the operational period, attend an operational briefing and then be transported to the "earthquake zone" for response activities.

Unlike most exercises, Response Exercise 2009 will provide CERT members the option to choose one of four participant levels - First Responder, Radio Operator, EOC Staff, and Observer. Participants choosing the first responder role will complete three full-scale scenarios over a four hour period.

At check-in, participants choosing the first responder role will be randomly placed into one of three "teams". After briefing the teams will pick-up any necessary supplies from Ground Support and respond to the impact area via bus. On arrival at the impact zone, the teams will each be confronted with a different earthquake related problem.

Scenario #1 - Commuter train derailment with multiple injured parties

Scenario #2 - Building collapse with rescue (Heavy Rescue unit on-scene)

Scenario #3 - Urban area search and rescue

Vehicular traffic	Team coordination

Each scenario will last 75 minutes. At the completion of the time, the teams will reassemble and be transported to the next scenario. First responder participants will complete all three scenarios.

Participants choosing the Radio Operator option will be assigned to function as communicator for one of the three teams (12), one of the on-scene public safety Branch Directors (3), or at the incident base in either the Incident Command Post (2) or the Communications trailer (3). Radio Operators should be licensed to operate amateur radios. Radios will be provided if the participant does not have their own portable radio. Non-licensed participants may be radio operators but will be limited to operating public safety radios.

Participants choosing the Emergency Operations Center option will be assigned to participate at the Base Camp in the Emergency Operations Center (EOC). Adjacent to the Incident Command Post, the EOC will be tracking the incident as it progresses, and will be managing requests from the field for resources and information as needed including determining hospital destinations for patients located during the exercise.

Participants choosing the Observer option will be able to observe the activities of the day without committing to any one scenario or activity. A shuttle bus will be available throughout the duration of the exercise to transport observers from the Base Camp to the scenario areas and back.

Upon completion of the three scenarios, all participants will be transported by bus back to the Base Camp for feeding and debriefing. A vendor display will also be located at the Base Camp for participants to view supplies and equipment available from a variety of disaster and emergency service vendors.
